BAC RESOLUTION NO. 2018-072
CONTRACT NO. ACU-2018

Procurement of five (5) Floor-Mounted Air-Conditioning Units (Inverter Type)

WHEREAS, the MWSS Board, in its meeting dated 11 October 2018, approved¹ the amendments to the MWSS-CO Revised Annual Procurement Plan (APP) for CY 2018 which includes Item # 21 – Other Machineries and Equipment – P800,000 was changed to Purchase of four (4) units Floor-Mounted Aircon – P800,000.00;

WHEREAS, on 25 October 2018, the Board, in its Resolution No. 2018-166-CO approved the Terms of Reference for the said procurement and increasing the quantity from 4 units to 5 units under the same Approved Budget for the Contract (ABC) of P800,000.00 to be installed at the following area:

QTY	LOCATION / AREA
1	5 th Floor – Board Room
1	4 th Floor – Administrator’s Conference Room
1	4 th Floor – beside the Administrator’s Conference Room
2	4 TH Floor – left wing area (Finance, OSD, HRODLD)

WHEREAS, the Request for Quotation (RFQ) was published at the Philippine Government Electronic Procurement System (PhilGEPS) and MWSS Website on 07 November 2018;


WHEREAS, Marco CO., Inc. responded to the RFQ and submitted its quotation before the deadline for submission not later than 1:00 PM, 15 November 2018;

WHEREAS, on 19 November 2018, the Technical Working Group (TWG) submitted to the BAC its detailed evaluation on the eligibility and technical submission of Marco Co. Inc. and recommended a failure of bidding because the financial proposal submitted by Marco Co., Inc. amounting to P1,002,713.01 exceeded the ABC by P202,713.01.

WHEREAS, on 26 November 2018, the TWG and Technical Estimating Committee submitted the revised Terms of Reference (TOR) and revised Approved Budget for the Contract, respectively;

WHEREAS, the revised ABC has been increased to P1,026,354.56 which will change the mode of procurement from Alternative Method to Competitive Bidding;

WHEREAS, upon review of the TOR, the BAC, in its meeting held on 07 December 2018, directed the TWG to revise the TOR to include the ABC and incorporate the Green Procurement Product (GPP) in the technical specification per GPPB Resolution No. 25-2017.

WHEREFORE, pursuant to Section 35.1 of the 2016 Implementing Rules and Regulations of Republic Act 9184, the Bids and Awards Committee (BAC) hereby **RESOLVED** to **DECLARE A FAILURE OF SMALL VALUE PROCUREMENT** for the Delivery, Installation, Testing and Commissioning of Five (5) Brand New Air-Conditioning Units (Floor Mounted Inverted Type).

RESOLVED FURTHER, the BAC **APPROVES** the **REVISED TOR** subject to the inclusion in the TOR of the following:

1. ABC amounting to P1,026,354.56, and
2. Green Procurement Product in the Technical Specification
