### **RESOLUTION NO. 2018-14 / 14**

#### **CONSULTANCY SERVICES FOR THE REVIEW OF DESIGN AND CONSTRUCTION MANAGEMENT/SUPERVISION OF THE NEW CENTENNIAL WATER SOURCE-KALIWA DAM PROJECT**

13 April 2018

WHEREAS, on 08 March 2018, upon the recommendation of the Bids and Awards Committee (BAC) per Resolution No. 2018-06(A) dated 28 February, the MWSS Board under Resolution No. 2018-045-CO, APPROVED the following relative to the procurement of Consultancy Services for the Review of Detailed Engineering Design and Construction Supervision/Monitoring of the New Centennial Water Source-Kalida Dam Project (NCWS-KDP) denominated as Contract No. NCWS-KDP 002-2018:

- a) The Bidding Documents consisting of Part I – Eligibility Documents and Part II – Instruction to Bidders;
- b) The Terms of Reference (TOR) which will form part of Part II Bidding Documents; and
- c) The Approved Budget for the Contract (ABC) in the amount of Three Hundred Sixty-Five Million Two Hundred Thirty Thousand Six Hundred Nineteen Pesos (Php365,230,619.00) chargeable against the CY 2018 Corporate Operating Budget (COB). The ABC will be the ceiling amount for the bidding.

WHEREAS, on 02 April 2018, the BAC through its Secretariat, published the Request for Expression of Interest (REI) at 1) the MWSS website ([www.mwss.gov.ph](http://www.mwss.gov.ph)); 2) Philippine Star; conspicuous places at MWSS; and 3) PhilGEPS;

WHEREAS, upon payment of Ten Thousand Pesos (Php10,000.00), the following five (5) bidders responded to the REI, to wit:

1. Engineering & Development Corporation of the Philippines (EDCOP)
2. Angel Lazaro & Associates International Consulting Engineers & Architects
3. Test Consultants (TCI)
4. Cest Incorporated
5. AECOM Philippines, Inc. (API)

WHEREAS, out of the five (5) Bidders, three (3) requested to extend the original Pre-Qualification Document submission deadline of 17 April 2018;

WHEREAS, the BAC deemed it reasonable to extend for fifteen (15) calendar days the submission of the Eligibility Documents to give sufficient time for the bidders to prepare their submissions;

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby RESOLVED, to APPROVE the extension of submission of Eligibility Documents

as contained in the REI for **fifteen (15) calendar days** from 17 April 2018 to 02 May 2018, not later than 1:00 PM, Philippine Standard Time.


