WHEREAS, the Metropolitan Waterworks and Sewerage System (MWSS), through its Corporate Operating Budget applied the sum of Twenty-Five Million Six Hundred Five Thousand Pesos (Php25,605,000.00) being the Approved Budget for the Contract (ABC) as payment under the contract for the Establishment of Network and IT Infrastructure Facilities and Design, Development, Testing and Deployment of Asset Management Information System with Contract No. NITIF-AMIS-2018;

WHEREAS, the Invitation to Bid was published at PhilGEPS, the MWSS website and at the Philippine Star on 05 October 2018;

WHEREAS, clarifications from the prospective bidders during the Pre-Bid Conference conducted on 12 October 2018 resulted in the issuance of two (2) bid bulletins revising certain provisions in the Bidding Documents;


WHEREAS, no bids were received as of 1:00 PM of 24 October 2018, the deadline set for the submission and receipt of bids.

WHEREFORE, pursuant to Section 35.1 of the 2016 Implementing Rules and Regulations of Republic Act 9184, the Bids and Awards Committee (BAC) hereby **RESOLVED to DECLARE A FAILURE OF BIDDING** for Contract No. NITIF-AMIS-2018 - Establishment of Network and IT Infrastructure Facilities and Design, Development, Testing and Deployment of Asset Management Information System.


RESOLVED FURTHER, the BAC directs the Technical Working Group (TWG) to determine the reasons for the failed bidding, and conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding the Documents, including its cost estimates as provided under Section 35.2 of the 2016 IRR-RA 9184.
