BAC Resolution No. 2018 –19

Award of Consultancy Services to Atty. Eugenio A. Insigne, as Free, Prior & Informed Consent (FPIC Consultant)

WHEREAS, the MWSS Vice-Chairman and Administrator, has determined the need to engage an experienced professional in completing the Free, Prior and Informed Consent (FPIC) process and Certification Precondition to be secured from the National Commission for Indigenous People for the Angat Water Transmission Improvement Project and the New Centennial Water Supply-Kaliwa Dam Project;

WHEREAS, the MWSS Board of Trustees approved the CY 2018 Annual Procurement Plan per Board Resolution No. 2017-16 CO dated 14 December 2017, which included the procurement of Consultants to do work that are primarily confidential for the Office of the Administrator under Sec. 53.7 of the Revised Implementing Rules and Regulations of the Republic Act No. 9184;

WHEREAS, under Sec. 53.7 of RA 9184, negotiated procurement may be resorted to in the case of individual consultants engaged to do work that is highly technical or primarily confidential and policy determining, where trust and confidence are the primary considerations for the hiring of consultants;

WHEREAS, on the recommendation of the Administrator, the MWSS Board of Trustees in a meeting held on 11 January 2018 approved the engagement of an FPIC Consultant and through Board Resolution No. 2018-010-CO issued on 25 January 2018 confirmed said approval;


WHEREAS, the BAC approved the Terms of Reference for the FPIC Consultant through Resolution No. 2018-05 and the same was advertised together with the Request for Expression of Interest at the Philippine Star on 18 January 2018, and posted at the MWSS' website.


WHEREAS, on 26 January 2018 Atty. Eugenio A. Insigne submitted his Expression of Interest for FPIC Consultant;

WHEREAS, the Administrator as end-user, considering the review and evaluation made on the credentials presented has determined that Atty. Insigne has the expertise, competence and wherewithal to deliver the goods and services required to be produced or to undertake the consultancy required by the MWSS.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby recommends to engage Atty. Insigne as FPIC Consultant, for a term of 6 months, renewable at the option of the Administrator, but in no case shall exceed his term, as provided under Sec. 53.7 of the Revised IRR of RA 9184.
