WHEREAS, the Board in its Resolution No. 2020-060-CO dated 28 July 2020, RESOLVED to approve the following for the procurement of **SUPPLY AND DELIVERY OF INDIVIDUAL DISASTER AND EMERGENCY PREPAREDNESS KIT FOR MWSS EMPLOYEES (CONTRACT NO. MWSS-DPK-2020)**:

- 1) Terms of Reference (TOR);
- 2) Increase of Approved Budget for the Contract submitted by the TEC amounting to One Million Five Hundred Twenty-Eight Thousand Nine Hundred Forty Pesos (Php 1,528,940.00); and
- 3) Authority of the Bids and Awards Committee (BAC) to initiate the procurement process under Competitive Bidding in accordance with the Revised Implementing Rules and Regulations of R.A 9184.

WHEREAS, on 18 September 2020, Invitation to Bid was posted at the Philippine Government Electronic Procurement System (PhilGEPS), MWSS Bulletin Board, and MWSS Website (www.mwss.gov.ph)

WHEREAS, on 1 October 2020, the BAC held its Pre-Bid Conference for the abovementioned project, however, no prospective bidders attended such conference;

WHEREAS, on 15 October 2020, the deadline for Submission and Opening of Bids, however, no submissions were received by the BAC;

NOW THEREFORE, the BAC hereby **RESOLVED** to approve the following for the **SUPPLY AND DELIVERY OF INDIVIDUAL DISASTER AND EMERGENCY PREPAREDNESS KIT FOR MWSS EMPLOYEES (Contract No. MWSS-DPK-2020)**:

1. To declare a FAILURE of Bidding for the **SUPPLY AND DELIVERY OF INDIVIDUAL DISASTER AND EMERGENCY PREPAREDNESS KIT FOR MWSS EMPLOYEES (Contract No. MWSS-DPK-2020)**;
2. To direct the TWG to Conduct a Mandatory Review and Evaluation of the Terms, Conditions, and Specifications in the Bidding Documents, including its Cost estimates and submit the same to the BAC; and
3. To undertake another procurement process under Competitive Bidding in accordance with the Revised Implementing Rules and Regulations of R.A 9184.





