**FOR THE PROCUREMENT OF AN EVENT ORGANIZER FOR THE CELEBRATION OF**  
**140<sup>TH</sup> ANNIVERSARY OF THE METROPOLITAN WATERWORKS & SEWERAGE**  
**SYSTEM- CORPORATE OFFICE (MWSS-CO)**

WHEREAS, the Metropolitan Waterworks & Sewerage System-Corporate Office (MWSS- CO) will celebrate its 140<sup>th</sup> Anniversary on 15 February 2018. The event is a milestone in the life of MWSS-CO as it continuously pursues its thrust of properly operating and maintaining waterworks system, to ensure an uninterrupted and adequate supply and distribution of potable water for domestic and other purposes, and the proper operation and maintenance of sewerage systems in its service areas;

WHEREAS, the 140<sup>th</sup> Anniversary Committee is inviting no less than the Philippine President himself, His Excellency Rodrigo Roa Duterte, to grace the event;

WHEREAS, the MWSS- CO deemed it proper to engage the services of an **EVENT ORGANIZER** with at least 15-year-experience in event planning such as conferences, corporate anniversaries, and other related activities attended by Philippine Presidents and other well-known personalities in politics and business. It will provide professional and sound advice to help meet the expected success of the celebration;

WHEREAS, the prospective bidders (event organizer) are required to present their latest similar completed projects or events within the last two (2) years. As indicated in the attached Terms of reference (TOR);

NOW, THEREFORE, the members of the Bids and Awards Committee (BAC) HEREBY APPROVE the conduct of procurement for the engagement of an Event Organizer for the celebration of the 140<sup>th</sup> Anniversary of MWSS-CO under Small Value Procurement with Approved Budget Cost (ABC) amounting to THREE HUNDRED FIVE THOUSAND PESOS (P305,000.00) inclusive of Government Taxes and other related charges.

Further RESOLVED, to delegate the conduct of the said procurement to the Office of the Administrator, being the end-user of this procurement, with able support from the BAC Secretariat.
