

Contract Agreement
SUPPLY and DELIVERY of POLO SHIRTS with Prints
For the Participants in the Recognition Day of the
Annual Million Trees Challenge

METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM (MWSS), a government owned and controlled corporation duly organized and existing under and by virtue of Republic Act No. 6234, as amended, holding office at 4th Floor, Administration Building, MWSS Complex, 489 Katipunan Road, Balara, Quezon City, herein represented by its Administrator, PDDG REYNALDO V. VELASCO (Ret) herein referred to as "The ENTITY"

AND

ELLISON ENTERPRISES CORPORATION, holding office at 68 Felix Manalo Street, Cubao Quezon City, herein represented by its General Manager, ELDRIDGE KESTER B. LIAO, herein referred to as "The Supplier".

ANTECEDENTS:

The ENTITY is in need of Printed Polo Shirts as tokens to the participants of the Recognition/Pledging Day of the Annual Million Trees Challenge (AMTC) as part of the celebration of MWSS' 140th Anniversary which will be held on 27 July 2018.

Pursuant to BAC Resolution No. 2018-29A approving the procurement of Supply and Delivery of Polo Shirts, the Request for Quotation (RFQ) and Terms of Reference were posted at PhilGEPS and MWSS Websites on 13 July 2018.

Of the three (3) suppliers that responded to the RFQ, only ELLISON ENTERPRISES CORPORATION was found complying in the documentary and technical specifications.

Having submitted a price proposal within the ABC amounting to Eighty-Eight Thousand Five Hundred Pesos (P88,500.00), ELLISON ENTERPRISES CORPORATION was declared the Single Calculated and Responsive Price Quotation.

WHEREFORE, in consideration of the foregoing, and the mutual covenants and agreements hereinafter set forth, the parties do hereby agree as follows:

1. The ENTITY hereby AWARDS to the SUPPLIER the contract for the Supply and Delivery of Polo Shirts for the AMTC on 27 July 2018.

3. The ENTITY shall pay the SUPPLIER the total amount of Eighty-Eight Thousand Five Hundred Pesos (P88,500.00), in the manner and in accordance with the Terms of Reference hereto attached not later than fifteen (15) days after submission of an invoice or claim by the SUPPLIER;
4. In consideration of the payments to be made by the ENTITY to the SUPPLIER, the SUPPLIER hereby covenants with the ENTITY to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract Agreement and the provisions of its attachments which are incorporated by reference under No. 2 above;
5. This Agreement shall be in effect until the ENTITY grant final approval and acceptance of deliverables by the SUPPLIER.


