**BAC RESOLUTION NO. 2018-50**  
**Procurement of Information Strategic Systems Plan (ISSP) for 2018-2020**

**WHEREAS**, on 24 August 2018, the MWSS Board approved the revised Annual Procurement Plan for MWSS Corporate Office under Resolution No. 2018-130-CO, which includes the procurement of Information Strategic Systems Plan for 2018-2020 ("ISSP") amounting to Twenty-Five Million Six Hundred Five Thousand (P25,605,000);

**WHEREAS**, the ISSP has been submitted to the Department of Information and Communications Technology (DICT) on 08 March 2018;

**WHEREAS**, pending the approval of the ISSP, on 13 July 2018, MWSS likewise submitted to the DICT clearance to procure all items indicated in the ISSP in view of the need to comply with the Major Final Outcome (MFO) for CY 2018 submitted to the Governance Commission for GOCC (GCG);

**WHEREAS**, the Estimating Committee, in its Memorandum to the Bids and Awards Committee (BAC) dated 14 August 2018, informed their incapability to determine the estimated cost of the ISSP and advised that the costings as budgeted in the ISSP submitted to DICT, once validated and approved by the latter, shall serve as the Approved Budget for the Contract (ABC);

**WHEREAS**, on 04 September 2018, the Technical Working Group (TWG) presented the Terms of Reference (TOR) to the BAC for the following ISSP components:

- 1) Supply, Installation and Configuration of Hardware, Software Design, Testing and Commissioning for the Development of Asset Management Information System (AMIS); and
- 2) Establishment of Network and Information Technology (IT) Infrastructure Facilities at the MWSS Corporate Office

**WHEREAS**, during the meeting, certain revisions in the TOR were made by the BAC.

**NOW, THEREFORE**, the members of the Bids and Awards Committee (BAC), in its meeting on 04 September 2018, hereby **RESOLVE TO APPROVE** the Terms of Reference for the procurement of the said ISSP components with an ABC of P25,605,000.00, subject to the revisions made by the BAC and approval of the CLEARANCE TO PROCURE by the DICT.
