**RENOVATION OF COMFORT ROOMS OF THE 3RD, 4TH and 5TH FLOORS
OF THE MWSS ADMINISTRATION BUILDING

WHEREAS, the members of the Board of Trustees, in its Resolution No. 2019-226-CO dated 13 December 2019, hereby **RESOLVE**, as it hereby **RESOLVED** to APPROVE for the Renovation of Comfort Rooms of the 3rd, 4th, and 5th Floors of the MWSS Administration Building (Contract No. MWSS-RCR 001-2019):

1. Terms of Reference (TOR) and Bidding Documents for the Renovation of Comfort Rooms of the 3rd, 4th and 5th floors of the MWSS Administration building (Contract No. MWSS-RCR 001-2019) subject to certain revisions in the Approved Budget for the Contract (ABC);
2. Authority of the Bids and Awards Committee to initiate the procurement process under Competitive Bidding in accordance with the Revised Implementing Rules and Regulations of R.A 9184 subject to the approval of the Board of Trustees.

WHEREAS, on 19 December 2019, the MWSS advertised and posted the Invitation to Bid for the Renovation of Comfort Rooms of the 3rd, 4th, and 5th Floors of the MWSS Administration Building (Contract No. MWSS-RCR 001-2019) at the Philippine Government Electronic Procurement System (PhilGEPS), bulletin board and the MWSS website (www.mwss.gov.ph);

WHEREAS, on 22 January 2020, the deadline for Submission and Opening of bids, only one (1) Prospective Bidder procured the bidding documents, and the BAC received only one (1) submission:




