**WHEREAS**, the BAC, in its Resolution No. 2019-64 dated 5 December 2019, **RESOLVED** to approve the following for the Procurement of Supply, Delivery and Installation of Brand-new Furniture, Fixtures, Appliances and Kitchenware and Utensils for the MWSS Directors' Quarters (Contract No. MWSS-FFAK-2019-21):

**WHEREAS**, on 18 September 2020, the Request for Quotation (RFQ) was posted at the Philippine Government Electronic Procurement System (PhilGEPS), MWSS Bulletin Board, and MWSS Website ([www.mwss.gov.ph](http://www.mwss.gov.ph));

**WHEREAS**, on 30 September 2020, the deadline for Submission and Opening of Quotations, however, no submissions were received by the BAC;
