WHEREAS, on 5 December 2019, the BAC through Resolution No. 2019-58 approved the following:

1. Declare a FAILURE of Bidding for the SUPPLY AND DELIVERY OF VARIOUS PERSONAL PROTECTIVE EQUIPMENT (PPE) FOR MWSS ENGINEERING AND TECHNICAL OPERATIONS GROUP (ETOG) AND WATER AND SEWERAGE MANAGEMENT DEPARTMENT (WSMD) (CONTRACT NO. MWSS-PPE-2019); and
2. Undertake another procurement process in accordance with the Revised Implementing Rules (IRR) and Regulations of Republic Act (RA) 9184.

WHEREAS, on 25 September 2020, the BAC through Resolution No. 2020-22 approved the following:

- a) **Revised Terms of Reference (TOR)** for the Supply and Delivery of Various Personal Protective Equipment (PPE) for MWSS Engineering and Technical Operations Group (ETOG) and Water and Sewerage Management Department (WSMD) (Contract No. MWSS-PPE-2019); and
- b) Initiate the Procurement Process under Small Value Procurement in accordance with the Revised Implementing Rules and Regulations of RA 9184.

WHEREAS, the SUPPLY AND DELIVERY OF VARIOUS PERSONAL PROTECTIVE EQUIPMENT (PPE) FOR MWSS ENGINEERING AND TECHNICAL OPERATIONS GROUP (ETOG) AND WATER AND SEWERAGE MANAGEMENT DEPARTMENT (WSMD) (CONTRACT NO. MWSS-PPE-2019) is included in the **Annual Procurement Plan (APP) (4th Revision)** approved by the Administrator on 18 November 2020 with an Approved Budget of the Contract (ABC) of Five Hundred Ninety-Nine Thousand Sixty Pesos (Php599,060.00);

WHEREAS, on 19 November 2020, the **Request for Quotation (RFQ)** was posted at the Philippine Government Electronic Procurement System (PhilGEPS), MWSS Bulletin Board, and MWSS website: www.mwss.gov.ph;

WHEREAS, on 02 December 2020, the deadline for Submission and Opening of Quotations, no submissions were received by the BAC;

NOW THEREFORE, the members of the BAC, hereby RESOLVED the following:

1. To declare a FAILURE of Bidding for the SUPPLY AND DELIVERY OF VARIOUS PERSONAL PROTECTIVE EQUIPMENT (PPE) FOR MWSS ENGINEERING AND TECHNICAL OPERATIONS GROUP (ETOG) AND WATER AND SEWERAGE MANAGEMENT DEPARTMENT (WSMD) (CONTRACT NO. MWSS-PPE-2019); AND
