BY REFERENDUM**

**PROCUREMENT OF COMMUNITY-BASED TREE PLANTING SERVICES FOR THE ANNUAL  
MILLION TREE CHALLENGE PROJECT (KALIWA WATERSHED)  
(CONTRACT NO. MWSS-2020-TPS)**

**WHEREAS**, the Procurement of Community-based Tree Planting Services for the Annual Million Tree Challenge Project (KALIWA Watershed) (Contract No. MWSS-2020-TPS) is included in the Annual Procurement Plan (APP) approved by the Administrator on 18 November 2020 with an Approved Budget of the Contract (ABC) of Six Million One Hundred Fifty Thousand Pesos (Php6,150,000.00);

**WHEREAS**, on 15 December 2020, the Board of Trustees through Resolution No. 2020-125-CO in its scheduled meeting approved the following:

- 1) Terms of Reference (TOR) for the Procurement of Community-Based Tree Planting Services for the Annual Million Tree Challenge Project (KALIWA Watershed) (Contract No. MWSS-2020-TPS);
- 2) Initiate the Procurement Process pursuant to Section 53.12 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184; and
- 3) Authorize the Administrator to negotiate with the Winning Bidder and sign the Notice of Award, Notice to Proceed and Contract Agreement for the Procurement of Community-Based Tree Planting Services for the Annual Million Tree Challenge Project (KALIWA Watershed) (Contract No. MWSS-2020-TPS).

**WHEREAS**, on 21 December 2020, the Request for Quotation (RFQ) was posted at the MWSS Website, MWSS Bulletin Board, and in public conspicuous places (General Nakar, Quezon Province);

**WHEREAS**, on 28 December 2020 at 11:00am, the deadline of submissions, no Quotation was received by the BAC;

**NOW THEREFORE**, WE, the members of the Bids and Awards Committee, **RESOLVED** to approve the following:

- a) Declare a FAILURE of Bidding for the Procurement of Community-based Tree Planting Services for the Annual Million Tree Challenge Project (KALIWA Watershed) (Contract No. MWSS-2020-TPS); and
- b) Direct the TWG to conduct Mandatory Review of the Terms of Reference subject to the approval of the BAC. After which, to recommend to the Board of Trustees to undertake another procurement process in accordance with the Revised IRR of RA 9184.
