**WHEREAS**, on 02 December 2020, the BAC through Resolution No. 2020-33 Approved the following:

1. To declare a FAILURE of Bidding for the Supply and Delivery of Various Personal Protective Equipment (PPE) for MWSS Engineering and Technical Operations Group (ETOG) and Water and Sewerage Management Department (WSMD) (Contract No. MWSS-PPE-2019); and
2. To undertake another procurement process under Small Value procurement in accordance with the Revised IRR of RA 9184.

**WHEREAS**, the Supply and Delivery of Various PPE for MWSS ETOG and WSMD (Contract No. MWSS-PPE-2019) is included in the Annual Procurement Plan (APP) for CY 2021 as approved by the Board through Resolution No. 2020-120-CO dated 20 December 2020 with an Approved Budget for the Contract (ABC) of Five Hundred Ninety-Nine Thousand Sixty Pesos (PHP 599,060.00);

**WHEREAS**, on 25 March 2021, the Request for Quotation (RFQ) for the project was posted in PhilGEPS, MWSS website and Bulletin Board;

**WHEREAS**, on 12 April 2021, the deadline for submission of quotations, only four (4) firms submitted their offers;

**WHEREAS**, in a BAC meeting held on 14 April 2021, the Detailed Evaluation results were presented by the TWG for approval of the BAC, summarized as follows:
