Procurement of Lease of Venue for the MWSS CO Officers' Strategic Planning
Workshop

**Contract No. PPPRD-LVSP-2020
BY REFERENDUM**

WHEREAS, the Bids and Awards Committee (BAC), in its Resolution No. 2020-11¹ dated 21 February 2020 approved the Terms of Reference, Request for Quotation, Reply Slip and Approved Budget for the Contract of Four Hundred Twenty Thousand Pesos (Php420,000) for the procurement of Lease of Venue for the MWSS CO Officers' Strategic Planning Workshop under Section 53.10 (Lease of Real Property and Venue) of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184

WHEREAS, on 11 March 2020, BAC Resolution No. 2020-13² resolved to AWARD the Contract for the Procurement of Lease of for the MWSS-CO Officers' Strategic Planning Work to Widus Hotel and Casino, Clark Freeport Zone, for having the Lone Calculated and Responsive Proposal;

WHEREAS, the proposed 2nights/3days live-in Strategic Planning is scheduled to be held from March 18 to 20, 2020;

WHEREAS, on March 16, President Rodrigo Roa-Duterte imposed an enhanced community quarantine (ECQ) or lockdown in Luzon, which includes the National Capital Region (NCR), restricting the movement of the population, in response to the growing pandemic of coronavirus disease 2019 (COVID-19) in the country;

WHEREAS, the ECQ restrictions imposed from March 18 to May 31, 2020 mandated the temporary closure of non-essential shops and businesses and prohibited mass gatherings and all means of public transportation to limit the movement of people;

WHEREAS, COVID-19 cases continue to rise in spite of the imposition of ECQ, Modified-ECQ and General Community Quarantine (GCQ) in Luzon and measures implemented by the Inter-Agency Task Force for the Emerging Infectious Diseases (IATF-EID) to bring down the infected cases to manageable level;

WHEREFORE, upon the recommendation of the Management, the Bids and Awards Committee (BAC) hereby **RESOLVED** to **CANCEL BAC RESOLUTION NO. 2020-13** Recommending the AWARD of Contract for *Lease of Venue for the MWSS CO Officers' Strategic Planning Workshop* denominated as Contract No. PPPRD-LVSP-2020 to WIDUS HOTEL AND CASINO in accordance to Section 41.C of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, which states that:

“For any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the GoP, as follows: (i) if the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE, (ii) if the project is no longer necessary as determined by the HoPE, or (iii) if the source of funds for the project has been withheld or reduced through no fault of the Procuring Entity.”

Approved by REFERENDUM: 30 June 2020 at Quezon City, Philippines.


