**BAC Resolution No. 2019- 58**

**SUPPLY AND DELIVERY OF VARIOUS PERSONAL PROTECTIVE EQUIPMENT (PPE)  
FOR MWSS ENGINEERING AND TECHNICAL OPERATIONS GROUP (ETOG) AND  
WATER AND SEWERAGE MANAGEMENT DEPARTMENT (WSMD)  
CONTRACT NO. MWSS-PPE-2019**

**WHEREAS**, on 5 September 2019, the BAC, under its Resolution No. 2019-45<sup>1</sup>, approved the following:

1. To declare a FAILURE of Bidding for the **SUPPLY AND DELIVERY OF VARIOUS PERSONAL PROTECTIVE EQUIPMENT<sup>1</sup> (PPE) FOR MWSS ENGINEERING AND TECHNICAL OPERATIONS GROUP (ETOG) AND WATER AND SEWERAGE MANAGEMENT DEPARTMENT (WSMD) (CONTRACT NO. MWSS-PPE-2019)**; and
2. To undertake another procurement process under Small Value Procurement in accordance with the Revised Implementing Rules and Regulations of R.A. 9184.

**WHEREAS**, on 13 November 2019, the MWSS advertised and posted the Request for Quotation for the Supply and Delivery of Personal Protective Equipment (PPE) for MWSS Engineering and Technical Operations Group (ETOG) and Water and Sewerage Management Department (WSMD) at the Philippine Government Electronic Procurement System (PhilGEPS) and the MWSS website ([www.mwss.gov.ph](http://www.mwss.gov.ph));

**WHEREAS**, on 18 November 2019, the deadline for Submission and Opening of bids, the following suppliers submitted their quotation, to wit:

2. To resort with the Negotiated Procurement as provided for in Section 35.5 of the Revised IRR of RA 9184.


