**BAC Resolution No. 2019- 62**

**FLEET CARD PROGRAM FOR THE PROCUREMENT OF FUEL (GASOLINE & DIESEL), LUBRICANTS, AND OTHER MAINTENANCE SERVICES  
CONTRACT NO. FCP-2018**

**WHEREAS**, on 7 June 2019 the BAC, under its Resolution No. 2019-31<sup>1</sup>, approved the following:

1. To declare the FAILURE of Bidding for Fleet Card Program for the Procurement of Fuel (Gasoline & Diesel), Lubricants, and other Maintenance Services Contract No. FCP-2018;
2. To resort with the Negotiated Procurement as provided for in Section 35.5 of the Revised IRR of RA 9184.;

**WHEREAS**, on 8 August 2019, the MWSS advertised and posted the Invitation to Bid for the Fleet Card Program for the Procurement of Fuel (Gasoline & Diesel), Lubricants, and other Maintenance Services at the Philippine Government Electronic Procurement System (PhilGEPS) and the MWSS website (www.mwss.gov.ph);

**WHEREAS**, no bidders attended in the Pre-Bid Conference held last on 23 August 2019 despite invitation to suppliers;

**WHEREAS**, on 5 September 2019, the deadline for Submission and Opening of bids, the only one supplier submitted their bid proposal:

**WHEREAS**, on 14 October 2019 BAC Meeting, the Technical Working Group (TWG) presented to the BAC its detailed evaluation. Based on the overall evaluation (presented below), the supplier failed to comply with the technical and financial requirements. Therefore, the TWG recommended declaring a failure of bidding:
