**WHEREAS**, the Board, in its Resolution No. 2019-53<sup>1</sup> dated 14 November 2019, approved the following for the Procurement of Supply, Delivery and Installation of Brand-new Furniture, Fixtures, Appliances and Kitchenware and Utensils for the MWSS Directors' Quarters (Contract No. MWSS-FFAK-2019-21):

1. Terms of Reference;

**WHEREAS**, on 18 November 2019, the Request for Quotation (RFQ) was posted at the Philippine Government Electronic Procurement System (PhilGEPS), MWSS Bulletin Board, and MWSS Website ([www.mwss.gov.ph](http://www.mwss.gov.ph));

**WHEREAS**, on 29 November 2019, the deadline for Submission and Opening of quotations, no submissions were received by the BAC;

**NOW THEREFORE**, the members of the BAC, in its meeting dated 05 December 2019, hereby **RESOLVED** the following:

1. To declare a FAILURE of Bidding for the **SUPPLY, DELIVERY AND INSTALLATION OF BRAND-NEW FURNITURE, FIXTURES, APPLIANCES AND KITCHENWARE AND UTENSILS FOR THE MWSS DIRECTORS' QUARTERS (Contract No. MWSS-FFAK-2019-21)**; and
2. To undertake another procurement process under Small Value Procurement in accordance with the Revised Implementing Rules and Regulations of RA 9184.
