The Contract is executed between:

METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM (MWSS), a government owned and controlled corporation duly organized and existing under and by virtue of Republic Act No. 6234, as amended, holding office at 4th Floor, Administration Building, MWSS Complex, 489 Katipunan Road, Balara, Quezon City, herein represented by its Administrator, PDDG REYNALDO V. VELASCO (Ret);

AND

AJA REGISTRARS, INC. (AJA), a Philippine Corporation holding office at 2F NOL Tower, Commerce Avenue, Maoridal Business Park, Ayala-Alabang, Muntinlupa City, herein represented by its authorized representative, **LAARNI T. NARIDO**, as confirmed in the attached Omnibus Sworn Statement.

ANTECEDENTS:

MWSS is in need of Consulting Services of an Accredited Certifying Body for the Issuance of ISO 9001:2015 Certificate and Surveillance Audits for the Quality Management System.

In a posting for Small Value Procurement at PhiGeps duly conducted under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, and in the evaluation and post-qualification of the submitted documents, AJA was declared to have the Lowest Calculated and Responsive Quotation that complies with the Eligibility Requirements, Technical and Financial Proposals.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


ACCORDINGLY, in consideration of the covenant and agreements hereinafter set forth, the services to be rendered and the sums of money to be paid, the parties do hereby agree as follows:

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. Contract Agreement
 - b. Terms of Reference
 - c. Request for Quotation

- d. AJA's Proposal, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents/statements submitted
 - e. Notice of Award of Contract
 - f. Performance Security
2. MWSS shall pay AJA the total amount of **TWO HUNDRED FIFTEEN THOUSAND AND EIGHT HUNDRED EIGHTY PESOS (P215,880.00)**, in the manner and in accordance with the Deliverables and Terms of Payments as indicated in the Terms of Reference and not later than sixty (60) days after submission of an invoice or claim by AJA;
 3. In consideration of the payments to be made by MWSS to AJA, AJA hereby covenants with MWSS to provide the services and to remedy defects therein in conformity in all respects with the provisions of this Agreement;
 4. MWSS hereby covenants to pay AJA in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract; and
 5. This Agreement shall be in effect until MWSS grant final approval and acceptance of deliverables by the CONTRACTOR.
