

Contract Agreement for the Engagement of Catering Services for the Recognition Day of the Annual Million Trees Challenge

METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM (MWSS), a government owned and controlled corporation duly organized and existing under and by virtue of Republic Act No. 6234, as amended, holding office at 4th Floor, Administration Building, MWSS Complex, 489 Katipunan Road, Balara, Quezon City, herein represented by its Administrator, PDDG REYNALDO V. VELASCO (Ret) herein referred to as "The ENTITY"

AND

LADY LYNN & SISTERS CATERING SERVICES CORPORATION, holding office at 84 L1 and 2 A Mabini Street, Birmingham Meadows, Burgos, Rodriguez, Rizal herein represented by its President and General Manager, MARILYN G. ROSALES, herein referred to as "The Provider".

ANTECEDENTS:

The Entity is in need of a Catering Services Provider to cater the Annual Million Trees Challenge (AMTC) Recognition and Pledging Day as part of the celebration of MWSS' 140th Anniversary which will be held on 27 July 2018.

Pursuant to BAC Resolution No. 2018-29 approving the procurement of Catering Services Provider, the Request for Quotation (RFQ) and Terms of Reference were posted at PhilGEPS and MWSS Websites on 07 July 2018.

Out of the three (3) providers that responded to the RFQ, only LADY LYNN & SISTERS CATERING SERVICES CORPORATION was found complying in the documentary and technical specifications.

Having submitted a price proposal within the ABC amounting to One Hundred Thousand Pesos (P100,00.00), LADY LYNN & SISTERS CATERING SERVICES CORPORATION was declared the Single Calculated and Responsive Price Quotation.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS: -

1. ACCORDINGLY, in consideration of the mutual covenants and agreements hereinafter set forth, the services to be rendered and the sums of money to be paid, the parties do hereby agree as follows:

1. The ENTITY hereby AWARDS to the PROVIDER the contract to Provide Catering Services for the AMTC on 27 July 2018.

- 3. The ENTITY shall pay the PROVIDER the total amount of One Hundred Thousand Pesos (P100,000.00), in the manner and in accordance with the Terms of Reference hereto attached not later than fifteen (15) days after submission of an invoice or claim by the PROVIDER;
- 4. In consideration of the payments to be made by the ENTITY to the PROVIDER, the PROVIDER hereby covenants with the ENTITY to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract;
- 5. The ENTITY hereby covenants to pay the SUPPLIER in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract; and
- 6. This Agreement shall be in effect until the ENTITY grant final approval and acceptance of deliverables by the PROVIDER.
