

**CONTRACT AGREEMENT FOR THE DESIGN, LAYOUT AND PRINTING OF THE  
2017 MWSS ANNUAL REPORT**

THE PUBLIC IS INFORMED:

The Contract is executed between:

METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM (MWSS), a government owned and controlled corporation duly organized and existing under and by virtue of Republic Act No. 6234, as amended, holding office at 4<sup>th</sup> Floor, Administration Building, MWSS Complex, 489 Katipunan Road, Balara, Quezon City, herein represented by its Administrator, PDDG REYNALDO V. VELASCO (Ret) herein referred to as "The ENTITY"

AND

ZURRANO PUBLISHING AND PRINTING CORPORATION, holding office at 1417 Vito Cruz Extension, Makati City, herein represented by its authorized representative, MARIA RACHEL Z. CHEN, herein referred to as "The Contractor".

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - a. PhilGEPS Bid Notice Abstract
  - b. Terms of Reference
  - c. Request for Quotation
  - d. Schedule of Requirements
  - e. The ENTITY's Notice of Award;
2. The ENTITY shall pay the CONTRACTOR the total amount of PHILIPPINE PESOS: One Hundred Ninety-Eight Thousand Eight Hundred Ninety-One (P198,891.00), in the manner and in accordance with the Schedule of Requirements hereto attached and not later than sixty days after submission of an invoice or claim by the CONTRACTOR;

The ENTITY hereby covenants to pay the CONTRACTOR in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract; and
5. This Agreement shall be in effect until the ENTITY grant final approval and acceptance of deliverables by the CONTRACTOR.
