ENGAGEMENT OF COMMUNITY-BASED TREE PLANTING SERVICES

THE PUBLIC IS INFORMED:

This Contract is executed between:

METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM (MWSS), a government owned and controlled corporation duly organized and existing under and by virtue of Republic Act No. 6234, as amended, holding office at 4th Floor, Administration Building, MWSS Complex, 489 Katipunan Road, Balara, Quezon City, herein represented by its Administrator, PDDG REYNALDO V. VELASCO (Ret), duly authorized by its Board of Trustees as confirmed by the attached Resolution No. 2018-126-CO;

AND

IPO WATERSHED PEOPLE'S ORGANIZATION FEDERATION, INC. (IWPOFI), a Philippine Corporation holding office at Brgy. Bigte, Norzagaray, Bulacan herein represented by its President, DELMA R. VARGAS, as contained in the attached Board Resolution No. 007-2018.

ANTECEDENTS:

MWSS has committed to plant 100,000 trees for 2018 under the its Annual Million Tree Challenge Program, of which, fifty thousand (50,000) trees are to be planted in Ipo Watershed Area. Hence, the need to engage the services a site-based group for the planting and maintenance.

Pursuant to Section 53.12 of the 2016 Implementing Rules and Regulations of Republic Act 9184 and the Manual on Community Participation in Government Procurement (CPPM) issued by the GPPB, the Request for Quotation was posted on 25 September 2018 at the MWSS website and in three (3) conspicuous places at Ipo Watershed premises, where the project will be implemented.

Among the three (3) participating organizations that submitted quotations before the deadline for submission on 02 October 2018, only Ipo Watershed People's Organization Federation Inc. is found to have completed with the requirements.

Accordingly, the parties hereby agree, as follows:

1. The following documents shall be deemed to form and be read and construed as part of this Agreement, as provided for under Section 37.2.3 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, viz:
 - a. Contract Agreement
 - b. Terms of Reference
 - c. IWPOFI's proposal and all other documents/statements submitted; and
 - d. Notice of Award of Contract

2. IWPOFI hereby covenants with MWSS to provide the services and remedy defects in conformity with the provisions of this Agreement;
3. MWSS shall pay IWPOFI the total amount in PHILIPPINE PESOS: Six Hundred Fifty Thousand Pesos (Php650,000.00) in the manner and accordance with the Payment Schedule provided in the Terms of Reference, not later than sixty (60) days after submission of an invoice or claim by IWPOFI;
4. This agreement shall be for a period of one (1) year commencing from the date stipulated in the Notice to Proceed (NTP); and
5. IWPOFI shall abide by all mandated labor laws and other government benefits enforced in the country.
