PROCUREMENT OF LEASE OF VENUE WITH FOOD AND ACCOMMODATION
FOR THE CONDUCT OF GAD MAINSTREAM/TEAM BUILDING
CONTRACT NO. SVP-19-HRODL-01

THE PUBLIC IS INFORMED:

This Contract is executed between:

METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM (MWSS), a government owned and controlled corporation duly organized and existing under and by virtue of Republic Act No. 6234, as amended, holding office at 4th Floor, Administration Building, MWSS Complex, 489 Katipunan Road, Balara, Quezon City, herein represented by its Administrator, PDDG REYNALDO V. VELASCO (Ret) Ph. D., duly authorized by its Board of Trustees as confirmed by the attached Resolution No. 2018-126-CO;

AND

CANYON COVE HOTEL AND SPA, INC. (SUPPLIER), a Corporation holding office at Far East Road, Piloto, Barangay Wawa, Nasugbu, Batangas 4231, herein represented by its Authorized Representative, Mr. REY MARK S. LATAG as contained in the attached Omnibus Sworn Statement dated 22 November 2018.

ANTECEDENTS:

MWSS through its Bids and Awards Committee (BAC) has undertaken the procurement for the Lease of Venue with Food and Accommodation for the Conduct of GAD Mainstream Planning/Team Building (Contract No. SVP-19-HRODL-01) in accordance with Section 53.9 - Small Value Procurement under the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184.

The Request for Quotation (RFQ) was advertised at the Philippine Government Electronic Procurement System (PhilGEPS) and MWSS Website (<http://mwss.gov.ph>) on 23 May 2019.

Two (2) suppliers responded to the RFQ and submitted quotations before the deadline for submission at 1:00 PM, 31 May 2019.

On 03 June 2019, the Technical Working Group (TWG), submitted to the BAC its detailed evaluation on the eligibility and technical submission of the 2 suppliers and finding the submission of CANYON COVE HOTEL AND SPA, INC. as the lone complying supplier.

On 07 June 2019, the BAC, finding the detailed evaluation conducted by the TWG to be sufficient and in order, recommended the award to the SUPPLIER.

On 07 June 2019, the Administrator, pursuant to BAC Resolution No. 2019-30 issued the Notice of Award to the SUPPLIER for the contract amount of Five Hundred Sixty-One Thousand Six Hundred Seventy-One Pesos (Php561,671.00).


Accordingly, the parties hereby agree, as follows:


1. The following documents shall be deemed to form and be read and construed as part of this Agreement, as provided for under Section 37.2.3 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, viz:
 - a. Contract Agreement
 - b. Terms of Reference
 - c. CANYON COVE HOTEL AND SPA, INC.'s proposal and all other documents/statements submitted; and
 - d. Notice of Award of Contract
2. The SUPPLIER hereby covenants with MWSS to supply and deliver the products and remedy defects in conformity with the provisions of this Agreement;
3. MWSS shall pay the SUPPLIER the total amount in PHILIPPINE PESOS: Five Hundred Sixty-One Thousand Six Hundred Seventy-One Pesos (Php561,671.00) in the manner and accordance with the Payment Schedule provided in the Terms of Reference, not later than sixty (60) days after submission of an invoice or claim by the SUPPLIER; and
4. The SUPPLIER agrees to defend, indemnify, and hold MWSS free and harmless from any and all claims, damages, expenses, fines, penalties, and/or liabilities of whatever nature and kind, whether in law or equity, that may arise by reason of the implementation of the Agreement.
