INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF SIX (6) MOTOR VEHICLES FOR THE METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM-CORPORATE OFFICE (MWSS-CO)

1. The Metropolitan Waterworks and Sewerage System through the Corporate Operating Budget (COB) 2019 intends to apply the sum of: (1) **THREE MILLION EIGHT HUNDRED EIGHTY THOUSAND PESOS (PhP 3,880,000.00)** for MWSS-MV-001-2018 (Section A) and (2) **EIGHT MILLION ONE HUNDRED TWENTY THOUSAND PESOS (PhP 8,120,000.00)** for MWSS-MV-001-2018 (Section B) being the Approved Budget for the Contract (ABC) to payments under the contract respectively for each section/item. Bids received in excess of the ABC for each section and likewise, bids with no 12%VAT shall be automatically rejected at bid opening.
2. The MWSS-CO now invites bids for the supply and delivery of two (2) Passenger Vans for Section A and four (4) Pick-up Vehicle for Section B, respectively, to the MWSS Corporate Office. Delivery of the Goods shall be within thirty (30) calendar days from receipt of the Notice To Proceed. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from Metropolitan Waterworks and Sewerage System- Corporate Office and inspect the Bidding Documents at the address given below during 9:00 AM to 4:00 PM on weekdays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **24 April 2019** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB indicated as follows:

Section	Cost of Bidding Documents (In Philippine Peso)
Bidders who will solely bid for Section A	PhP 5,000.00
Bidders who will solely bid for Section B	PhP 10,000.00
Bidders who will bid both for Section A and B	PhP 15,000.00

It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the MWSS-CO.

6. The MWSS-CO will hold a Pre-Bid Conference on **07 May 2019, 9:00 AM** at MWSS Bulwagan, 5th Floor, Administration Building, MWSS Complex, Katipunan Road, Balara Quezon City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **23 May 2019, 1:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **23 May 2019, 1:30 PM** at MWSS Bulwagan, 5th Floor, Administration Building, MWSS Complex, Katipunan Road, Balara Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. **Late bids shall not be accepted.**

8. The bidder has the option of submitting a bid on either or both sections. Evaluation and contract award shall be undertaken on per section basis.
9. The MWSS-CO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
