INVITATION TO BID
(RE-BIDDING)

The Metropolitan Waterworks and Sewerage System (MWSS) through its Disposal Committee, created by virtue of Office Order No. 2018-125 dated July 26, 2018 will conduct a public bidding (re-bidding) for the disposal without cost of one (1) lot composed of thirty six (36) units of old and dilapidated MWSS employees' quarters located at Balara Filters Compound, Brgy. Pansol, Balara and La Mesa Dam, Novaliches, Quezon City on an "as-is, where is" basis.
