Procurement of Design, Layout and Printing of 2017 MWSS Annual Report

WHEREAS, pursuant to BAC Resolution No. 2018-25, which approved the procurement of printing services for the 2017 MWSS Annual Report, the Request for Quotation (RFQ) together with the Terms of Reference (TOR) were posted at Phil-GEPS and MWSS websites on 28 June 2018;

WHEREAS, in response to the postings, ten (10) suppliers submitted their bids for the procurement before the closing date at 1:00 P.M. of 06 July 2018, and they are the following:

WHEREAS, out of the ten (10) who submitted bids, three (3) suppliers, namely: Gilcor Printing Press, New Age Graphics, Inc. and Kayumanggi Press, Inc. were found non-complying for not submitting samples of designs and layout projects with at least 60 pages;

WHEREAS, out of the remaining seven (7) suppliers who were found complying in the documentary requirements and technical specifications, ZURBANO Publishing and Printing Corporation submitted the lowest price quotation amounting to One Hundred Ninety-Eight Thousand Eight-Hundred Ninety-One Pesos (Php198,891.00);

WHEREAS, a post-qualification evaluation was conducted on ZURBANO Publishing and Printing Corporation and it was determined that all the documents submitted were ascertained to be authentic and valid;






