The **Metropolitan Waterworks and Sewerage System (MWSS) Corporate Office** through its Bids and Awards Committee (BAC) invites qualified Contractor to submit a price proposal for the Procurement of Contractor for the Proposed Renovation and Rehabilitation of the Balara Director's Quarters/Guest House, with the **Approved Budget for the Contract (ABC) at Nine Hundred Seventy Thousand Pesos Only (Php 970,000.00)** inclusive of 12% VAT and all taxes and duties.

1. All particulars relative to this procurement shall be conducted in accordance with the Revised Implementing Rules and Regulation (IRR) of Republic Act 9184.
2. The **ABC is Nine Hundred Sevety Thousand Pesos (Php 970,000.00)** inclusive of 12% VAT and all taxes and duties.
3. The proposal shall be duly signed by the authorized representative and shall contain the following:

At least ONE (1) government building construction/renovation project amounting to at least half the Approved Budget for the Contract (ABC). <p><u>Non-compliance to both (1) and (2) qualification requirements above constitute a ground to be classified as NON-ELIGIBLE.</u></p>

Only projects completed by the Bidder itself, or by any, or both of the JV partners, in case of joint venture, duly supported by certificate of completion

issued by the client or any other equivalent document to prove successful completion of the project shall be considered in the evaluation for determining the bidder's score.

The Bidder shall demonstrate that he has adequate core team of experienced and competent personnel.

The Bidder shall also demonstrate that it has on-going projects whether or not similar in nature with this project to be bid out by the MWSS.

4. All interested bidders are allowed to visit the site on **December 07, 2018 (Friday)** at **2:00PM** and shall coordinate with the Operations Support Department (OSD), 4th Floor MWSS Building, Katipunan Road, Balara, Quezon City.
5. The ABC is **Nine Hundred Seventy Thousand Pesos (Php 970,000.00)** inclusive of 12% VAT and all taxes and duties. Any financial proposal exceeding the ABC shall not be accepted and failure to include the 12% VAT shall be a ground for its automatic rejection.
